



Colony Management Guidelines

The following guidelines must be followed to ensure that your colony is being properly cared for and in compliance with the TNR ordinance.

Caretaker: a person who provides food, water, shelter and on-going health monitoring for a colony (group) of stray and feral cats.

Colony: is a group of stray and feral cats that frequent an area seeking food and/or shelter.

1. All the cats in the colony, even those that visit sporadically, need to be fixed, eartipped for identification, vaccinated for rabies, and returned to their familiar outdoor home.
2. Provide adequate food and water for the cats on a daily basis.
3. Provide adequate shelter for the cats in the colony (ideas available on our website)
4. Ensure that any cats that are injured or ill receive prompt treatment.
5. **Keep your clinic treatment records for all your colony cats. They provide proof of spay/neuter and rabies vaccination. (This is required by Animal Care and Control)**
6. Make efforts to place tame colony cats and kittens with adoption groups as resources allow.
7. If you are moving or can no longer properly care for your colony, contact IndyFeral as soon as possible for assistance in helping you identify an alternate caretaker.
8. Make your colony cats good neighbors. Provide adequate shelter, food and an area to eliminate so they do not become a nuisance to your neighbors.

Failure to follow these guidelines puts the cats at risk by increasing the chance the colony will become a nuisance, forcing Animal Control authorities to impound the cats. TNR coupled with proper feeding, shelter and on-going health monitoring stops the unchecked breeding of the cats, improves their lives and allows the colony to diminish naturally over time.
